3. Policy

A. Privacy Policy

Peace Lutheran Church reviews our Privacy Policy periodically, and we reserve the right, at our discretion, to add, modify, or remove portions of this Privacy Policy at any time. Peace Lutheran Church will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of the website, or we are legally obligated to retain this data for longer time periods.

E. Analytics
